Bridge Growth’s principals have a long history in the federal contracting sector. Credit Suisse served as financial advisor to Bridge Growth and provided debt financing commitments in support of the transaction. GoldPoint Partners provided mezzanine debt financing and an equity co-investment. Willkie Farr &

Gallagher LLP served as legal advisor for Bridge Growth. Schulte Roth & Zabel LLP served as legal advisor for Veritas and CRGT.
